## Dear Parishioners,

Once again, I would like to take this opportunity, while presenting the Parish Financial Statement to the end of the calendar year 2021 to acknowledge my personal thanks and support you have extended to me in the past year.

This financial report highlights your continued commitment to support the daily running costs of the Parish estate through the weekly collection. It also reflects your on-going commitment to Trócaire and the special Diocesan collections.

The financial year 2021 as in the previous cycle was particularly challenging for parish finances and for families in our parish community. The uncertainty continues into this financial cycle, with inflationary costs in relation to energy costs, food inflation and fuel consumption. Reduced Mass attendance in uncertain times has inevitably taken its toll on parish income. However, we are very grateful to the increasing numbers of parishioners who are now using the provision of standing orders to support the parish. As previously stated, the renovation of St. Joseph's Church is an on-going priority which has unfortunately been stalled due to Covid.

**Information Meeting - St. Joseph's Church:** There will be an Information Evening regarding engagement of the community led by a HLF (Heritage Lottery Fund) representative in the Community Hall on Thursday 30<sup>th</sup> June at 8pm. Discussion will evolve around heritage and the proposals to secure funding for the community and the renovation of the church.

You will note from the income figures presented for this financial year to the Glenullin Renovation account – amounting to £17.658.00 which we gratefully acknowledge. No Legacies or Bequests were received in this period.

I respectfully request, if possible, that consideration might be given by those who use envelopes, and who do not presently use the 'white envelope' – that they might even consider a monthly donation, to remit the costs that will infinitely accumulate as we go forward pertaining to the maintenance of the parish estate and the renovation of St. Joseph's Church. I ask also for your consideration to avail of the Gift Aid scheme available to those who pay income tax and use parish envelopes and standing orders.

Your continued generosity is very much appreciated in providing for the upkeep and development of the parish and the support of others who are in need of our help.
